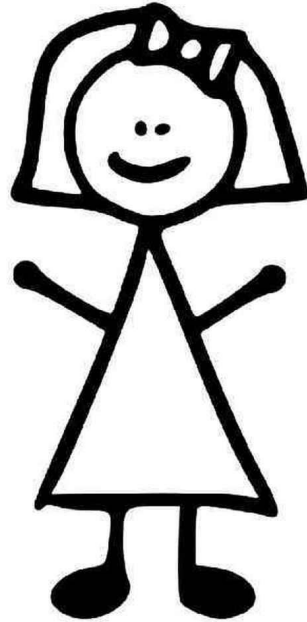

Reminder: Internal Deadline Policy



- Deadline policy went into effect January 6, 2020
- Two levels of service (Full and Limited) based on when finalized proposal and approved PAF arrive in ORSP



Internal Deadline Policy Pro Tips!



- Pay close attention to Question 1.2 regarding purpose for routing PAF:
 - To process the submission of a proposal
 - To request review/negotiation of an agreement
 - Both
- Log Project Team Submission ASAP or PAF may end up being cancelled

Agency Updates: NSF



- New PAPPG released, effective June 1, 2020
- Must use SciENCv for generation of Biosketch and Current & Pending Support



Agency Updates: NSF Current & Pending



- C&P includes all resources made available to an individual in support of or related to his/her research efforts, whether they have monetary value or not.
- C&P includes in-kind contributions, whether or not intended for use in the proposed project.
- C&P must be provided for proposed project, ongoing projects, and any proposals currently under consideration, regardless of source or recipient.

Agency Updates: NSF C&P FAQ



- Gifts excluded (cannot have expected effort commitment)
- In-kind contribution with *associated effort commitment*
 - If used in project, describe in Facilities, Equipment, Other Resources
 - If not used in project, describe in Current & Pending Support
- In-kind contribution without *associated effort commitment*
 - If used in project, describe in Facilities, Equipment, Other Resources
 - If not used in project, do not report

Agency Updates: NIH



- Effective January 5, 2020, the Executive Level II salary cap is \$197,300.
- New GPS released, effective October 1, 2019
- Adopts clarified definition of “Other Support” from July 2019 notice



NIH's Definition of Other Support (OS)



- All resources made available to researcher or senior key personnel...
- in support of and/or related to all of their research endeavors...
- whether they have monetary value or not and...
- whether they are located at U-M or not.
- Excludes training awards, prizes, gifts or U-M start-up support.

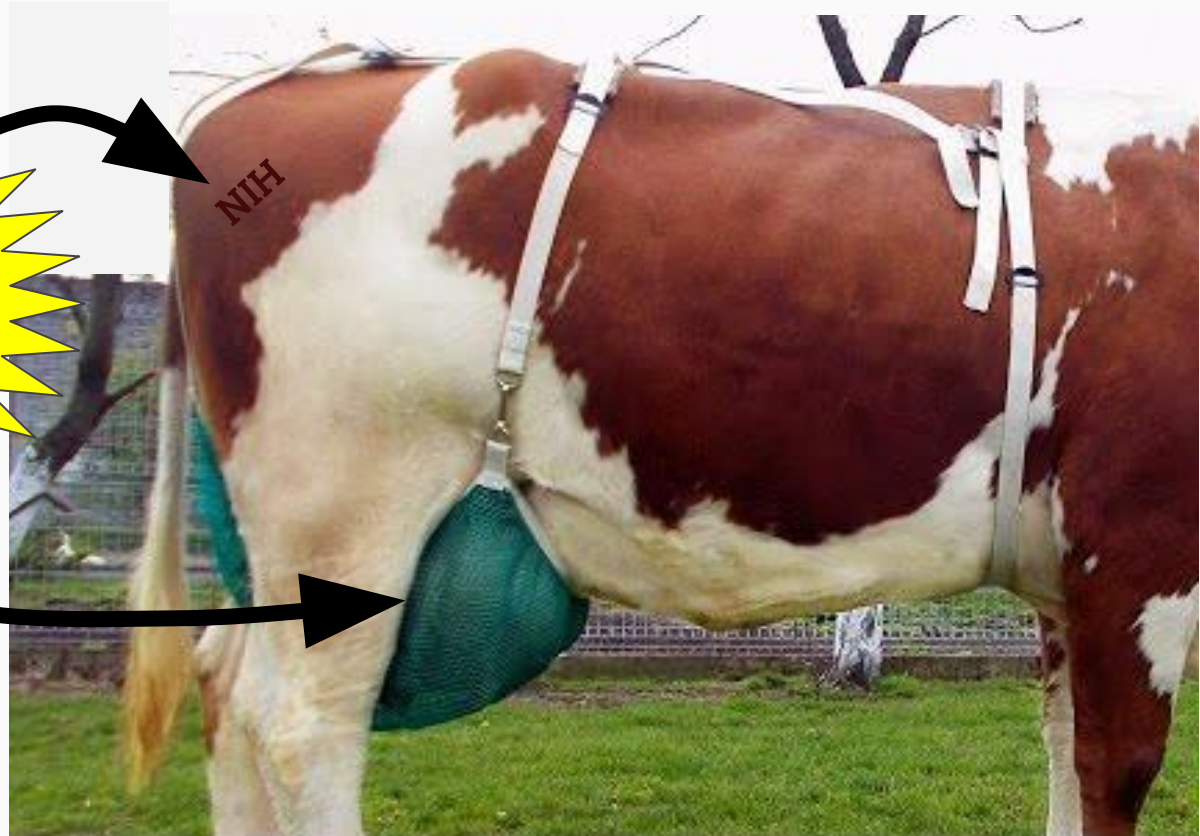


- All U-M investigators on PAF will be required to sign the PAF, not just the PI.

Privacy & EU: Political-Legal History



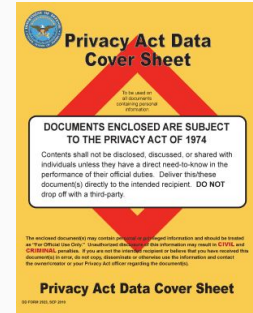
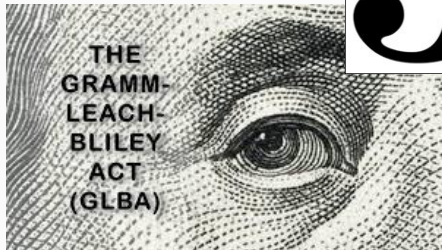
1948: UN Declaration of Human Rights (Art. 12)

- *No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks*

1995: Directive 95/46/EC of the European Parliament on the protection of individuals with regard to the processing of personal data and on the free movement of such data (Art. 1, 1)

- *In accordance with this Directive, Member States shall protect the fundamental rights and freedoms of natural persons, and in particular their right to privacy with respect to the processing of personal data*

Privacy & the U.S.: Legal History

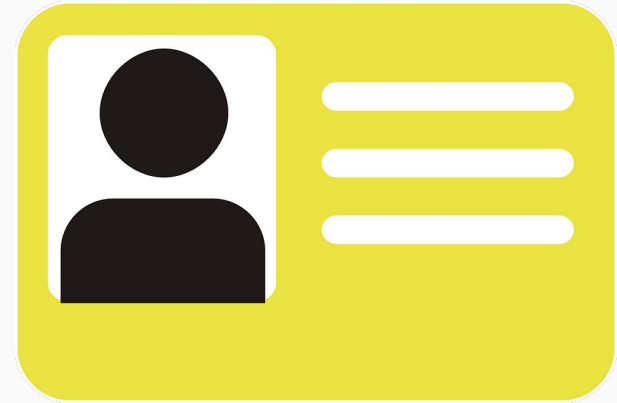


What Is Personal Data?



Any information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to, among other things, an identifier such as a name, an identification number, location data, or an online identifier.

The GDPR requires that personal data be processed “lawfully” and establishes several bases for the lawful processing of personal data.

Why & When GDPR May Apply

GDPR Basics



EU General Data Protection Regulation is a legally enforceable regulation passed to replace the EU Data Protection Directive.

Goal of the GDPR: To harmonize the regulations and protections for individuals with respect to data processing and to safeguard the free flow of information between member states, and the world.

GDPR will attempt to regulate data controllers and processors inside and outside of the EU.

GDPR enforcement began May 25, 2018.

Why Does GDPR Apply to U-M



GDPR may apply to the University of Michigan in certain circumstances because:

1. We engage in business activities that may collect or process the personal data of individuals residing in the EU; and
2. We work with controllers or processors that are located in the EU and they may contractually obligate us to comply.

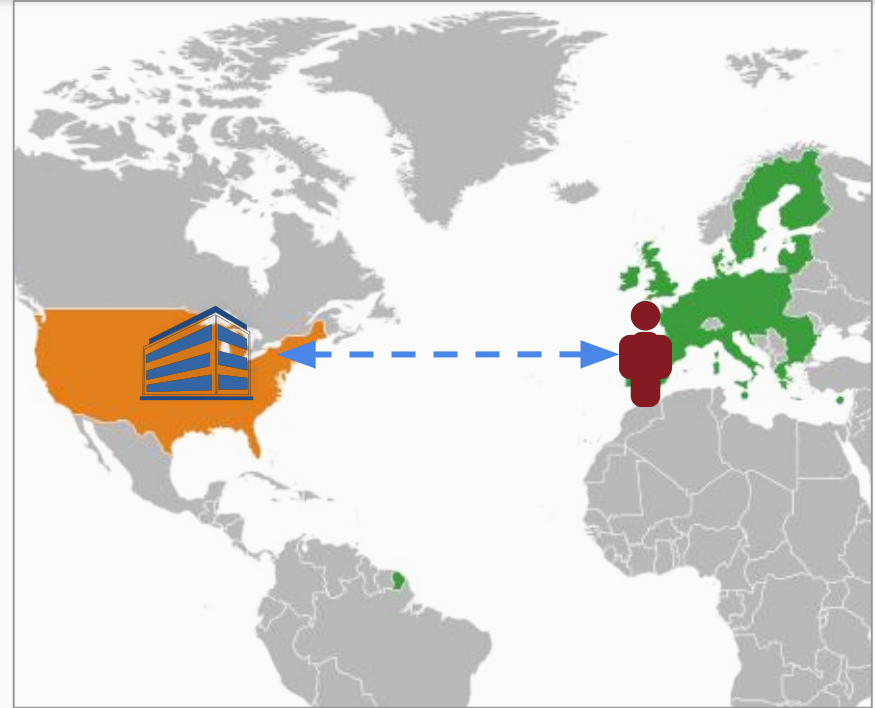
When the GDPR May Apply: U-M Examples



A cohort of non-EU students is participating in a semester-long study abroad in Italy, Belgium, and UK.

Office of Development is engaged in a fundraising campaign and is collecting donor information from alumni residing in the EU.

A research consortium in the EU provides the University of Michigan with the personal data of EU citizens for research analysis.



When the GDPR Does Not Apply: U-M Examples



- An ex-pat research group, made up for EU citizens who are students at U-M is formed on campus. They meet to discuss how GDPR impacts them.
- EU faculty are recruited at an academic conference held in Orlando, FL.
- Students from the EU are present on campus in Ann Arbor and take part in a research project where their data is collected and analyzed.

CONTEXT

Research participants, from whom you are actively collecting data, are physically present in an EU/EEA country*.

*Current EU country members include: Austria, Belgium, Bulgaria, Croatia, Republic of Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden

*Current EEA country members include: All EU countries and Iceland, Liechtenstein and Norway



IDENTIFIABLE 'NATURAL' PERSONS

Data collected includes direct identification or indirect identification (e.g., use of coded data w/ key)*

*'Pseudonymisation' is "the processing of personal data in such a manner that the personal data can no longer be attributed to a specific data subject without the use of additional information, provided that such additional information is kept separately and is subject to technical and organisational measures to ensure that the personal data are not attributed to an identified or identifiable natural person."

Anonymous Data \neq Personal Data



SENSITIVE DATA

Includes but not limited to questions about:

- Sexual orientation or sexual practices
 - Racial or ethnic origin
 - Political opinions
 - Trade union memberships
- Religious or philosophical beliefs
 - Genetic data
- Biometric data (where processed to uniquely identify someone)
 - General health information



Some Simple Examples

- Researcher is gathering data from MTurk online survey.
- Researcher is gathering data via face-to-face interviews with international students at the U-M.
- Researcher is collecting data about political opinions from individuals in a grocery store parking lot in Germany.

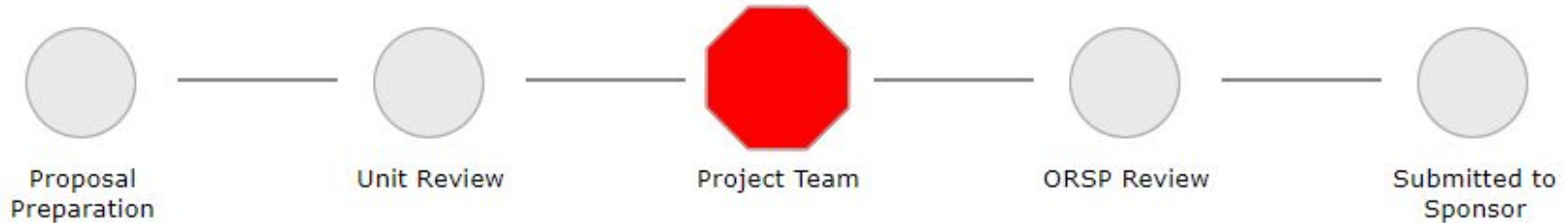
